Directions to home (start from office):

- 1) **To Rte. 93:** Turn right onto N. Main St (Rte 106) At 2<sup>nd</sup> set of traffic lights turn left onto Meredith Center Rd. At the end of the road turn left onto Rte. 104. Go past the gas stations and turn right onto I 93 N.
- 2) **To Rte. 3:** Turn right onto N. Main St. (Rte 016) and continue straight through 2<sup>nd</sup> set of lights (Parade Rd). At the round about take 1<sup>st</sup> right to go South on Rte. 3 or take the 3<sup>rd</sup> right to go North on Rte. 3.
- 3) **To Rte. 106:** Turn left. At 1<sup>st</sup> set of lights turn left onto Church St. At lights turn right onto Union Ave. At the lights turn left onto Rte. 106.
- 4) **To Rte. 107:** Follow directions above onto Rte. 106. Follow signs and bear left onto Rte. 107.
- 5) **To Rte. 3 West:** Follow directions above onto Rte. 106 but go straight (onto Court St) at the lights at the intersection of Union Ave. and Rte. 106.
